**DIVE LEADER MEMBERSHIP AGREEMENT 2010**

For and in consideration of **SSI** certifying or renewing the Dive Leader, the Dive Leader agrees to abide by the following provisions and requirements:

1. The Dive Leader agrees to abide by rules and regulations now and hereafter established for and put forth by SSI.
2. The Dive Leader agrees to follow the Scuba Schools International System, including but not limited to, the SSI Dive Leader Manual, as it currently exists or is modified.
3. The Dive Leader agrees that while acting as a scuba Dive Leader, he/she shall act only in such a manner as will bring credit to himself/herself, his/her SSI Authorised Dive Center, and to SSI.
4. The Dive Leader agrees to maintain any and all such records as are required by SSI, original records to remain property of the SSI Authorised Dive Center.
5. The Dive Leader agrees to provide access to such records as needed by SSI or the SSI insurance company.
6. The Dive Leader agrees to meet or exceed the educational standards as now and hereafter established by SSI.
7. The Dive Leader agrees to comply with the annual re-certification procedures as are stipulated by SSI.
8. The Dive Leader understands that if he/she has been inactive or in non teaching status for a period of six (6) consecutive months or more, renewal of active Dive Leader status is subject to a review procedure, and renewal is at the sole discretion of SSI.
9. The Dive Leader understands that he/she will be subject to a monitoring process established by SSI Authorised Dive Center as part of the Dive Leader's annual re-certification procedures.
10. The Dive Leader agrees to promptly and immediately report to SSI any accidents of any nature.
11. The Dive Leader understands that he/she may acquire certification materials only through an SSI Authorised Dive Center, and that Dive Leader certification is valid only when operating under the auspices of an SSI Authorised Dive Center in good standing.
12. The Dive Leader understands that if he/she is charged with a criminal offence, his/her Dive Leader status will immediately be placed on inactive status. Should the Dive Leader be convicted of a criminal offence, the Dive Leader's SSI certification will be subject to immediate revocation by SSI.
13. The Dive Leader understands that he/she may not affiliate with an SSI Authorised Dive Center as a satellite Dive Leader without prior written approval from SSI Headquarters.
14. It is strongly recommended but not required that the Dive Leader is to carry scuba Dive Leader's professional errors and omissions liability insurance, which on the face of such insurance policies, shall protect himself/herself and SSI from any and all liability for loss or damages, including but not limited to liability for bodily injury or loss of life.
15. The Dive Leader understands that he/she is not an agent, employee, or legal representatives of SSI and has no authority to bind SSI in any manner.
16. Because SSI is unable to directly monitor the Authorised Dive Center/Dive Leader's instructional process and business practices, it is clearly understood that certification cards and all other materials are issued by SSI to their Authorised Dive Center as a service. It is the sole responsibility of the Authorised Dive Center and their Dive Leaders to assure that every person who receives SSI certification meets all criteria established in the published SSI Training Standards. Authorised Dive Center/Dive Leader further agrees not to issue certification to any person who in any way fails to meet the intent as well as the letter of standards.
17. Certification as an SSI Dive Leader in no way entitles the Dive Leader to an SSI Authorised Dive Center, or in any way implies that the Dive Leader has any right to such Authorised Dive Center.
18. Certification as an SSI Dive Leader in no way implies that the Dive Leader is entitled to attend courses leading to Dive Leader certifications beyond Open Water Instructor.
19. The Dive Leader understands that his/her Dive Leader renewal is not solely based on submission of the renewal application fee. SSI Dive Leader renewal is subject to annual review and acceptance by SSI.
20. The Dive Leader agrees that he/she has not previously been or is not currently the subject of any investigation, action or proceeding brought by any scuba diving association or organization. Should the Dive Leader become the subject of any such investigation, action or proceeding during the term of this Agreement, SSI may, in its sole discretion, terminate his/her certification.
21. The Dive Leader authorises any other scuba diving association or organization with which he/she is affiliated to release to SSI any and all records and other information pertaining to any investigation, action or proceeding involving him/her.
22. The Dive Leader authorises SSI upon request to release to any other scuba diving association or organization with which he/she is affiliated any and all records and other information pertaining to any investigation, action or proceeding involving him/her.
23. The Dive Leader is expected to pay accounts due to SSI. Failure to pay accounts due will result in loss of Dive Leader status and collection proceedings.

**The Dive Professional agrees and understands that if he/she should default under this agreement, his/her certification as a SSI Dive Professional may be immediately revoked, at the sole discretion of SSI Headquarters, and in addition, SSI shall have all other legal and equitable remedies as a result of such default.**
